CONDITIONS

- 1. Work shall include surface preparation, placement of asphalt and aggregate chips, required sweeping until minimal loose aggregate remains, and rolling of the roadway shoulders after sweeping to compact any loose aggregate.
- 2. Sweeping of aggregate shall begin no sooner than three days and no later than 7 days after placement. All roads shall be swept at least two to three times until there is minimal loose aggregate on the roadway surface. After sweeping all roadway shoulders shall be rolled with a steel drum roller to compact loose excess aggregate on the shoulders.
- 3. Contractor is responsible for all traffic control during the chip-sealing process.
- 4. Contract costs shall include placement of advance notice signs at least 2 weeks before the start of the work. Signs shall indicate that "CHIP SEAL WILL BEGIN WEEK OF ______", and shall be placed at the end points and intersections of through roads and at the entrance intersection of each non-through road or cul-de-sac.
- **5.** No work shall be performed unless there is 40% or less chance for rain and the air temperature is at least 60 degrees and rising.
